## Agreement

# on scientific and technical cooperation between State Institution ''The Republican Research Center for Radiation Medicine and Human Ecology'' and ...

SI "The Republican Research Center for Radiation Medicine and Human Ecology" (Republic of Belarus) in the person of the director of the Center Alexander Rozhko, on the one hand, and the ....., in the person of the .... of the .... and ......, on the other hand, recognizing the importance of scientific cooperation and expressing the desire to carry it out on a long term basis, have agreed on the following.

### **Section 1**

The Parties agreed to develop and deepen cooperation in the field of science on the principles of equality, mutual benefit and mutual assistance in accordance with the current legislation of the Republic of Belarus and ...

Cooperation is carried out on the basis of mutual consent, taking into account the interests of both Parties without derogation from the rights of third parties.

#### **Section 2**

In accordance with this Agreement, scientific and practical cooperation between the Parties will be carried out in such forms as:

the development and expansion of joint research programs, projects, as well as the exchange of knowledge gained in the course of their implementation;

joint publication of research results, as well as other scientific literature; to exchange of scientists and specialists for joint scientific research;

mutual exchange of research information, documentation, literature, and other information;

organization and holding of bilateral joint meetings, board meetings, scientific seminars, conferences on topics and programs of mutual interest;

participation of scientists and specialists in conferences and scientific meetings, seminars, symposia, congresses organized by one of the Parties;

advanced training of scientists and specialists by organizing joint seminars, scientific conferences, working meetings and internships.

#### **Section 3**

In furtherance of joint research programs, projects and developments, the Parties may involve scientific, research and other organizations, as well as individual scientists and specialists.

## **Section 4**

Scientific information that is obtained as a result of joint activities of the Parties within the framework of this Agreement, except for information on that make confidential information, may be disseminated by the Parties only in accordance with the current legislation of the Republic of Belarus and...

#### **Section 5**

The Parties shall protect the rights associated with patents, the protection of samples and other copyrights to industrial and intellectual property that may be created as a result of cooperation under this Agreement in accordance with the applicable law requirements of the Parties.

The issues of protection and use of the results of joint scientific research and associated information shall be coordinated in accordance with the current legislation of the Republic of Belarus and ..., in each case separately by concluding separate contracts and (or) agreements, based on the applicable law requirements of the Parties.

The Parties acknowledge that the information obtained as a result of scientific cooperation under this Agreement and recognized as confidential is published only with the consent of the other Party.

The Parties agreed that the obligation to preserve the confidentiality of the information remains in force after the expiration of the contract (or its early termination) within the next three years.

#### Section 6

To merge the efforts the Parties have agreed on the following:

- To inform each other about own industrial property objects pertaining to the subject of cooperation, to which applications were submitted prior to the conclusion of the contract, and also during the period of the Agreement;
- To create the necessary conditions for joint submission of applications for obtaining protection documents for the industrial property objects created as a result of research activity.

Legal protection and use of industrial property objects created as a result of joint cooperation shall be ensured taking into account the equal share of the Parties.

#### Section 7

The Parties may establish joint committee for cooperation in the field of science to coordinate cooperation within the framework of this agreement and develop joint rules, procedures and plans.

### **Section 8**

This Agreement may be amended or supplemented by mutual Agreement of both Parties.

Any amendments or supplementations shall be documented in separate protocols and (or) additional agreements which shall be an integral part of the given Agreement and shall enter into force in order contained herein.

Disagreements regarding the interpretation and application of the provisions of this agreement will be resolved by the parties through negotiations and consultations.

#### **Section 9**

This Agreement carries no financial obligations between the Parties.

## **Section 10**

The present Agreement shall enter into force upon its signing.

The present Agreement is made in two copies, in the English and Russian languages, both having the same force.

This Agreement shall be in effect for a period of five (5) years after which it is automatically renewed for the same period and may be terminated by either Party, with notification to the other Party not less than three months.

Termination of this Agreement will not affect the implementation of scientific work on cooperation carried out in accordance to this Agreement and uncompleted by the end of its term.
